

## Kysela Père et Fils, LTD. TERMS and DELIVERY RATES

### Payment Terms

1. Virginia – C.O.D.- Immediate payment/no terms
2. Washington D.C. – 15 days from date of invoice
3. Maryland
  - **List week** – 45 day terms from date of invoice
  - **Non-List week** – 30 day terms from date of invoice
4. National Accounts
  - **FOB VA orders:** First order is prepaid. Subsequent orders have payment terms of 30 days from date of departure from the Winchester warehouse (FOB VA). The initial prepaid order will receive a discount of 3%, and subsequent FOB VA wine orders receive a 2% discount, unless otherwise stated (no discount on beer orders). The 2% discount is given to support sampling and corked/off bottles, as KPF does not accept bill backs.
  - **Domestic winery-direct orders:** Domestic winery-direct shipments have terms of 60 days from date of departure from the winery, and domestic brewery-direct shipments have terms of 30 days from date of departure from the brewery.
  - **Containerized cargo:** payment terms are 60 days from date of departure from port for shipments from France. Payment terms are 90 days from date of departure from port for shipments from Australia, Austria, Chile, Germany, Italy, New Zealand, Portugal, and Spain. Full assorted containers from Calatayud, Argentina, and South Africa have terms of 120 days from date of departure. Any DI-related freight charges billed by KPF have 30 day terms.
